1. Introduction

Zebra is introducing the RS5000x, a high-performance corded imager wearable scanner for use in warehouses, distribution centers, and manufacturing operations. The RS5000x is worn on one finger and enables omnidirectional scanning of both 1D and 2D barcodes. The RS5000x is compatible with the WT6400, WT6300 and WT6000 wearable terminals. The RS5000x offers unrivaled 2D scan performance in a single finger format, with a rugged industrial design that will withstand the harsh freezer environments down to -30°C in warehouse and manufacturing.

The RS5000x wearable scanner offers the following features:

- Corded operation that draws power from the host device with no need for battery or Bluetooth connectivity
- High performance SE4770 imager scan engine, with laser aimer
- Omnidirectional scanning of 1D and 2D barcodes
- Rotating manual trigger, for operation on either right hand or left hand
- Two trigger options standard trigger for use over finger or light gloves, and a larger trigger for use over heavy freezer gloves.
- High-endurance nylon finger straps with cam-type buckle
- Two color red / green LED for notification
- Operating temperature of -22°F to +122°F/-30°C to +50°C
- Withstands multiple 4 foot / 1.2 meter drops to concrete, over the temperature range
- IP65 sealing

9. Frequently Asked Questions

- Q Who is the RS5000x corded wearable scanner designed for?
- A. Zebra designed the RS5000x for customers who are seeking high performance scanning in hands-free workflows in warehouses, manufacturing, transportation & logistics and cold chain operations.
- Q. Will the corded RS5000 be discontinued when the RS5000x is released?
- A. No, the RS5000x will be sold alongside the RS5000.
- Q. Which Zebra wearable computers are compatible with the RS5000x?
- A. The RS5000x connects to either the left or right side ports on the WT6400, WT6300 and WT6000 wearable computers.
- Q Is the RS5000x compatible with the WT41N0?
- A. No, the RS5000x cannot be used with the WT41N0. For customers with an install base of legacy WT41N0, the RS419 and RS5000 will remain available for sale.
- Q. Does the RS5000x require a battery?
- A. No, the RS5000x draws power from the WT6400, WT6300 or WT6000 wearable terminal.
- Q. What mounting options are available for the RS5000x?
- A. Two finger mount options are available for the RS5000x A standard trigger that is designed to be worn on bare fingers or light gloves, or a large trigger designed to be used over heavy gloves, especially in freezer environments. Both trigger versions use a durable nylon strap with cam-buckle to secure the RS5000x scanner on the finger.
- Q. Can both trigger versions be used in freezer environments?
- A. Yes, both versions of the RS5000x are rated for operation down to -30°C. Please note that freezer operation requires the use of the extended battery used in the wearable terminal.
- Q. How is the RS5000x different from and RS5000?
- A. The RS5000x uses the SE4770 imager scan engine which provides better motion tolerance than the SE4710 imaging scan engine used in the RS5000. Therefore, the RS5000x provides more consistent scanning decode at distance and when workers are in motion. Also, the RS5000x has a laser aimer which offers clearer targeting compared to the LED dot aimer in the RS5000.



- Q. What is the life cycle of the RS5000x?
- A. The RS5000x has a 5+5 year life cycle, offering 5 years of sale and 5 years of support after end of sale.
